Your Freedom of information Act request below has been granted. Your individual requests are set forth below, along with the District's responses.

Request #1: Record of teachers receiving surplus notice due to the closing of kindergarten classrooms in school year 2015-2015 following the board meeting on July 14, 2015.

Response to Request #2: Please see the attached P & P forms for the 3 teachers who received surplus notice they were transferred to new positions due to the closing of kindergarten classrooms in school year 2015-2016.

Request #2: The letter or any notice sent to families about the kindergarten classrooms being closed in school year 2015-2016 following the board meeting on July 14, 2015. Only one copy of the letter is needed, not all the letters to all the families.

Response to Request #2: Please see the attached letter. While we understand and appreciate the fact that you have not requested copies of all the letters, we are sending copies of all the letters in response to request #3 and #4 below.

Request #3: Record showing the number of students who will have to be relocated due to the closing of kindergarten classrooms in school year 2015-2016 following the board meeting on July 14, 2015.

Request #4: Schools which students will move into due to the closing of kindergarten classrooms in school year 2015-2016.

Please note we consider the names and address of incoming kindergarten children private information exempt from disclosure pursuant to 5 ILCS 140/7(1)(b), and we have redacted this information from the letters provided.

Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
