Hello Mr. Wang,

The District received your freedom of Information Act request for:

Any and all documents that reflecting the name of any attorney substituting for Lori Hoadley at any school board meeting since her hire by the school district.

Your request has been granted in part and denied in part. Attached please find copies of the open and closed session Board meeting minutes that have been made available to the public under Section 2.06 of the Open Meetings Act. The District also has closed session minutes responsive to your request from 9/23/14 and 12/22/14 which have not been released for public inspection, and are exempt from disclosure pursuant to 5 ILCS 140/7(1)l. Please also note that we have redacted signatures in the documents as unique personal identifiers pursuant to 5 ILCS 140/7(1)(b).

To the extent you consider this response a denial of your request, you have a right to have this response reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11. If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
