Thank you for your response.

Can I get the in-school suspensions? Yes. I would like those as well. Can those be identified as in-school, separately from the out-of-school suspensions.

Then, could I get the expulsions separate as well.

Multiple students -- That's probably really important to what the data shows.

I definitely don't want a list of all in-school suspensions and out-of-school suspensions and expulsions and not be able to note how many of them are repeated.

Can I get every student who was disciplined by in-school, out-of-school or expulsion as a single record for each student showing that individual student's discipline as well as district-wide totals for in-school, out-of-school and expulsion?
