Please note that District #205 issues purchase orders for individual employee and consultant expense reimbursements. The PO detail for these reimbursements may contain personal home addresses, personal phone numbers, personal email addresses, employee ID#s and social security numbers. This personal information has been redacted from the attached spreadsheet. 5 ILCS 140/2, 5 ILCS 140/7(1)(b) and 7(1)(c). The remaining documentation you requested in #1-#6 is contained in the attached spreadsheet.

To the extent you consider this response a denial of your request, you have a right to have this response reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11. Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
