Terms and Conditions:

1. Prices quoted are valid for 30 days unless otherwise specified. All orders are subject to approval by our credit department.
2. A 50% deposit is requested prior to order.
3. Terms are net 15 days from date of invoice. A service charge of 2% per month will be added to all delinquent invoices. Customer shall not withhold payment in excess of the selling price of the specific merchandise that has not been delivered or is subject to repair and/or replacement.
4. Pricing is based on payment in cash, check or ACH. A 3% convenience fee will be added to invoice if a credit card (American Express, Visa or Mastercard) is used for purchases over \$2,500. Credit cards will be charged in full at time of order.
5. All product is made to order; therefore, all sales are final. All requests for changes in quantity or specification shall be in writing and if approved, additional charges may apply.
6. Widmer will provide 30 days free storage (free storage does not apply to projects that are planned to be direct shipped or received-on-site direct from the manufacturer). Beyond 30 days, a 1% (of sell price) charge per month will apply. In the event of a delay, the merchandise will be considered accepted by the customer for purposes of payment. The customer has the right to withhold 5% of the invoice amount against completion of delivery.
7. When the customer receives a direct shipment of product, it is the customer's responsibility to inspect the merchandise at time of receipt and file any freight claims per the manufacturer's stipulated timeframe. Widmer cannot be held responsible for damaged goods when product is shipping directly to the customer.
8. Unless otherwise noted, delivery and installation will be made during normal business hours and based on non-prevailing wage labor. Additional costs will apply for overtime or additional work requested by the customer. Risk of loss transfers to the customer once the product is on site.
