



**Rockford School District #205, Winnebago-Boone Counties Illinois** is a special charter district organized under a special charter granted by the Illinois General Assembly February 15, 1865. The District is governed by the laws for school districts serving a resident population of not fewer than 1,000 and not more than 50,000. The School District constitutes a body corporate that possesses all the usual powers of a corporation for public purposes. The District offers a rich and varied curriculum to its 28,800 students. It is one of the largest school districts in Illinois and the second-largest employer in the Rockford region. The Rockford Public Schools is focused on the five goals and nine strategies in its strategic plan. The district's vision is to be first choice for all families.

The approximate amount of the 2019-2020 operating budget is \$460.9 million. The District currently employs approximately 4,890 full and part-time employees. No fees shall be charged for the first 50 pages of black and white, letter or legal sized copies. After the first 50 pages of black and white copies, a fee of .15 shall be charged. For copies of audio video material or color copies, the actual cost of the media or copies shall be assessed. All original records must remain on the premises and all copying shall be done in the presence of the below-mentioned individuals or their designees:
